Art Event Company Limited has a guideline to conduct business with ethics according to the principles of good governance, adhering to responsibility towards society and all stakeholders.

The Company will establish this Whistle Blower Policy as a channel for directors, executives, employees, and all stakeholders to file complaints in the event of any violation of human rights practices, risks in the supply chain, or concerns about other matters, or to report any significant fraud or corruption such as illegal actions, violations of regulations, violations of the Company's policies, and violations of business ethics, to help improve or take corrective action to ensure appropriateness, transparency, and fairness.

The information of the complainant or whistleblower will be kept confidential to prevent rights violations.

Guidelines for Practice

Any employee or person related to the Company may file a complaint or report any wrongdoing by submitting a written report to the Company's management representative. The executive representative will then conduct a preliminary study to determine whether the information and clues are likely to be fraudulent or wrongdoing, and if necessary, will conduct a further investigation.

Where the allegation does not provide sufficient suspicion of corruption or wrongdoing and no investigation is required, the Management Representative will inform the complainant or whistleblower of why an investigation is not being conducted.

However, if the reported matter is considered to have a possibility of corruption or wrongdoing, the executive representative will be responsible for investigating and reporting to the managing director with recommendations on how to handle it.

Measures to protect complainants or whistleblowers of wrongdoing

1. The Company will keep confidentiality of the information and identities of the complainants, whistleblowers, and the person being complained of. The complainants or whistleblowers will not be at risk of losing their jobs or having their reputations affected in any way.
2. If the Company needs to disclose information, the Company will disclose only necessary information and has received consent, taking into account the safety and damage of the complainant and the whistleblower as important, including consulting with the complainant or whistleblower before taking any action.
